## Exhibit A

## **RENTAL RULES**

- 1. Smoking is allowed outside only. Do not smoke in the house or in screened in porch. Extra charges apply if house interior smells like smoke.
- 2. People other than those in the Guest party set forth above may not stay overnight in the property. Any other person in the property is the sole responsibility of Guest. Guests are not allowed to exceed the occupancy limit agreed to above.
- 3. Guests should not create excessive noise at a level that disturbs neighbors; Code-enforced neighborhood quiet hours are from 10:00 p.m. 8:00 a.m.
- 4. The Homeowners are not responsible for any accidents, injuries or illness that occurs while on the premises or its facilities. The Homeowners are not responsible for the loss of personal belongings or valuables of the guest. By accepting this reservation, it is agreed that all guests are expressly assuming the risk of any harm arising from their use of the premises or others whom they invite to use the premise. Guests acknowledge the inherent dangers of a hot tub and lake particularly with respect to small children and assume all liability with respect to thereof.
- 5. Keep the property and all furnishings in good order
- 6. Only use appliances for their intended uses
